Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. Form HUD-50075-ST is to be completed annually by **STANDARD PHAs** or **TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.





Staff provided an overview of the significant changes to the plan, including incorporating provisions in the City's Rent Control Ordinance and the Fair Chance Ordinance. Receiving no written comments/questions from any of the RAB members present, staff used the summary of proposed changes for a guided discussion

Administrative Plan

1. Concern that residents had been advised by former Executive Director that the ordinance would apply to Section 8, but not Public Housing.
There is no language in the Ordinance exempting Public Housing units/tenancies. The Ordinance applies equally to the Section 8 Voucher and Public Housing Programs.
2. Fear that Proposition 47, which reduces felonies to misdemeanors will mean RHA won't be able to deny or terminate offenders
The Fair Chance Ordinance includes language specific to felony convictions. The Ordinance was approved by City Council, and staff is compelled to comply, unless and until the Ordinance is revised. Staff will be meeting with representatives of the legal advocates to discuss various concerns.
3. Do federal regulations governing the Section 8 and Public Housing programs trump local requirements?
Clarified, local ordinances cannot preempt federally mandated provisions, but can be applied where there is discretion. For example, RHA cannot provide rental assistance to any individual convicted of manufacturing methamphetamine in public housing; there is discretion however for the length of time considered for criminal background checks.
4. Concern that window for reviewing criminal history reduced from five to two years
The change is required to comply with the Fair Chance Ordinance
5. Will the limits on information that RHA can provide a prospective landlord make it harder for families with Section 8 vouchers to find housing?
Owners rely on RHA to help with referrals and support when a household is not complying with lease terms. The revised standards will decrease the information provided, and may be reason for concern by some landlords. In terms of supply, the market is changing, and increases in RHA Payment Standards over the past 12 months have increased the supply of units available to families with Section 8 Vouchers.

6. How does the "Earned Income Disregard" affect program participants that are self-employed?

Any previously unemployed or under-employed disabled individual that experiences an increase in earned income household is eligible for the Earned Income Disregard. Under-employed is defined as "a person who has earned, in the twelve months previous to employment, no more than would be received for 10 hours of work per week for 50 weeks at the established minimum wage"

7. Is there a requirement for minimum or maximum annual income in the Section 8 or Public Housing Program?

There is no minimum income requirement. An assisted household can have \$0 rent, and receive a monthly payment from RHA in the form of an allowance for tenant paid utilities. There is no maximum income cap. However, in the Section 8 program if the tenant rent portion (30% of adjusted monthly income) equals the contract rent (so RHA is not paying any subsidy) participation is terminated after 6 months.

In the Public Housing program, households with increasing annual income often elect the "Flat Rent" over an income based rent to minimize family rent. A new provision is included that will allow any household with annual income at or above 100% Area Median Income to remain in the unit by paying the Section 8 Fair Market Rent.

8. How long is the income disregard period?

There are two periods. During the initial disregard period, 100% of the increase attributed to an increase in earned income is disregarded for 12 months. During the second disregard period, 50% of the increase attributed to an increase in earned income is disregarded for 12 months.

9. How much time does a household have to report an increase in income?

Any increase in income must be reported to RHA within 14-days. A household may, but it is not required to report a decrease in income [a decrease in income may result in a decrease in tenant rent]

10. What is the requirement for reporting changes in earnings from self-employment that is not constant reported?

RHA is required to anticipate annual income for the next 12 month period. Staff works with families to make accurate projections; revisions are made throughout the year to address any significant variations – upon a report from the family. To the extent it makes sense (assuming things have stabilized), actual earnings are used for the next year projection.

11. How often is the landlord required to change the carpet?

There is no requirement for replacing carpet or other flooring. The unit must remain safe, decent and sanitary – and pass the annual inspection. RHA considers the age, condition and quality of flooring in response to any owner request for an increase in contract rent.

Admissions and Continued Occupancy Policy

12. Can the Ordinance be revised to allow RHA to consider arrests, not just felony convictions? This is especially true for properties like Nevin Plaza, when many residents rely on a private (unsupervised) elevator to travel to and from the living unit

That is something that can be discussed with the legal advocates, and as appropriate, presented to City Council for consideration.

13. Does this mean that a person on parole or probation could be allowed to reside at Nevin Plaza?

Yes. Having a parole or probation status does not mean the person poses a threat to neighbors. To the extent that staff is aware of the status, we can be on the alert, and in a position to assure other residents that the situation is being properly managed.

14. If a person is elderly (62) or disabled, and over-income, do they have to leave (in Section 8)?

The lease is between the owner and the family. Under Richmond's Rent Ordinance the owner must have just cause to terminate a tenancy without the consent of the tenant. The fact that RHA is no longer paying a portion of the rent is not "just cause".

Capital Projects

Staff advised imminent plans to "reposition" Nevin Plaza and Nystrom Village to provide for comprehensive rehabilitation. Residents would receive tenant protection vouchers that would allow them to secure housing, and continue paying 30% of adjusted monthly income for rent. After rehabilitation, residents would have the first right to return.

Thus, the projects proposed are closely aligned to activities to address safety.

15. RHA should investigate options for the fire exits – to prevent unauthorized entry

Staff will explore with the Fire Department, the option of making the doors open out only.
