**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, FOR AUTHORIZATION TO ACCEPT AND APPROPRIATE THE  
NATIONAL FOOTBALL LEAGUE FOUNDATION FUNDS IN AN AMOUNT NOT TO  
EXCEED \$250,000 FOR THE MARTIN LUTHER KING FIELD TURF  
REPLACEMENT PROJECT**

**WHEREAS**, the National Football League Foundation (“NFL”) in partnership with LISC Sports and Recreation (“LISC”) issued a Request for Proposals (“RFP”) in 2018 for the Grassroots Program grant funds to benefit low income residents or communities within NFL target markets; and

**WHEREAS**, the City of Richmond, a municipal corporation and a charter city, applied and was awarded the Grassroots Program grant for the Martin Luther King field turf replacement project; and

**WHEREAS**, the City of Richmond has received and accepted the Agenda Report regarding this Resolution.

**NOW, THEREFORE, BE IT RESOLVED THAT**, the City Council of the City of Richmond finds the above recitals accurate and have served together with the Agenda Report as the basis for the findings and approvals set forth in this Resolution.

**BE IT FURTHER RESOLVED THAT**, the City of Richmond hereby agrees to use the Grassroots Program funds for eligible activities in the manner presented in the application as approved by the NFL and LISC and in accordance with Program Regulations.

**BE IT FURTHER RESOLVED THAT**, the City Council authorizes the City Manager or her designee to execute in the name of the City of Richmond, the Grant Agreement, and all other documents required by the State for participation in the Grassroots Program, and any amendments thereto and accept and appropriate the grant funds.
