

**RESOLUTION NO. 93-20**

**A RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
APPROVING A CONTRACT WITH AQUATIC HARVESTING INC., AND A BUDGET  
AMENDMENT TO THE HILLTOP LANDSCAPE DISTRICT BUDGET TO TRANSFER  
RESERVE FUNDS INTO THE OPERATING BUDGET**

**WHEREAS**, on June 30, 2020, the Richmond City Council approved the FY 2020-21 budget for the Hilltop Landscape Maintenance District (“District”) and the annual engineers report prepared by SCI Consulting Group (“Report”) for the District; and

**WHEREAS** bids were solicited from three Lake Ecosystem contractors and Aquatic Harvesting Inc. was the low bidder with a bid in the amount of \$30,150 to trim the cattails blocking the primary drainage outfall/spillway to water level and the repair of the damaged weir outlet gate at the Hilltop Lake and

**WHEREAS**, a budget amendment is needed to transfer \$75,000.00 from the reserve fund to the operating budget for the District to pay for the Aquatic Harvesting Inc. contract and continue working on final fix which include additional biological studies and Federal and State permits; and

**WHEREAS**, the \$75,000.00 will be used for proposed Hilltop Lake deferred maintenance project as set forth in the Agenda Report in support of this Resolution; and

**WHEREAS**, the City Manager will be authorized to execute all required documents and contracts to perform deferred maintenance at the Hilltop Lake in the amount not to exceed the \$75,000.00.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that the Council of the City of Richmond, California, that the Hilltop Landscape District budget for FY 2020-2021 be amended to reflect the transfer of \$75,000 from the reserve fund into the operation budget for deferred maintenance projects as set for in the Agenda Report in support of this Resolution.


