**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
AUTHORIZING CONTRACT ALLOCATION INCREASE BY \$600,000 TO  
AMOUNT NOT TO EXCEED \$1,200,000 AND A TWO YEAR CONTRACT TIME  
EXTENSION PER CONTRACT FOR A TOTAL OF FIVE YEARS FOR AS-NEEDED  
ARCHITECTURAL, LANDSCAPE ARCHITECTURAL, PROJECT  
MANAGEMENT AND ENGINEERING SERVICE CONTRACTS AMANDMENTS  
FROM JULY 1, 2021 THROUGH JUNE 30, 2023**

**WHEREAS**, the Richmond Public Works Department will be delivering an approximate \$40 million CIP Program in the next three years; and

**WHEREAS**, the Richmond Public Works Department is currently managing the delivery of Via Verdi Slide Restoration, Boorman Park Rehabilitation, Central Avenue Traffic Improvements, Yellow Brick Road, Richmond Auditorium Lighting Improvements, Harbour 8 Park Extension, Miraflores, Facility Roof Replacements, BTA Park and Community Center Enhancements, Fire Station 63 Improvements, etc; and,

**WHEREAS**, the Richmond Public Works Department is managing as-needed consultant contracts with Mark Albertson Architects-MA, Vallier Design Associates, Inc., mack5 and NCE consultant firms to deliver the above mentioned projects; and

**WHEREAS**, the above mentioned as-needed consultant contracts expire on June 30, 2021 and their contract capacities are reaching their original approved contract allocations:

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Richmond, California, hereby authorizes the Public Works Department to enter into amended Service Contracts for as-needed Architectural, Landscape Architectural, Project Management and Civil Engineering Services with Mark Albertson Architects-MA, Vallier Design Associates, Inc., mack5 and NCE consultant firms to increase their contract allocations by \$600,000 for a total amount not to exceed \$1,200,000 and to grant their two year contract extensions from July 1, 2021 to June 30, 2023;
