

RESOLUTION NO. 136-20

**A RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, TO ACCEPT THREE GRANTS FROM EAST BAY COMMUNITY
FOUNDATION, KAISER PERMANENTE NORTHERN COMMUNITY
BENEFIT PROGRAM AND THE CALIFORNIA ENDOWMENT AND
ADJUST APPROPRIATIONS BY \$95,000 AND EXPENDITURES BY
\$95,000 IN THE 2020-2021 OFFICE OF NEIGHBORHOOD SAFETY BUDGET**

WHEREAS, subsequent to the adoption of the 2020-2021 City of Richmond operating budget, the Office of Neighborhood Safety was awarded \$95,000 in grants from the East Bay Community Foundation, Kaiser Permanente Northern Community Benefit Program and The California Endowment, and

WHEREAS, the additional funding of \$95,000 will be used to provide general and emergency support services for Office of Neighborhood Safety (ONS) Operation Peacemaker Fellowship participants supported by ONS street outreach efforts, and

WHEREAS, subsequent to the adoption of the 2020-2021 City of Richmond operating budget, the Office of Neighborhood Safety was awarded a \$30,000 grant from East Bay Community Foundation (EBCF), and

WHEREAS, subsequent to the adoption of the 2020-2021 City of Richmond operating budget, the Office of Neighborhood Safety was awarded a \$30,000 grant from the Kaiser Permanente Northern Community Benefit Program, and

WHEREAS, subsequent to the adoption of the 2020-2021 City of Richmond operating budget, the Office of Neighborhood Safety was awarded a \$35,000 grant from The California Endowment, and

WHEREAS, the additional funding of \$95,000 will be used to provide general and emergency support services to the Office of Neighborhood Safety and

WHEREAS, the grant funding will significantly expand and support the Operation Peacemaker Fellowship Program, and

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Richmond that the 2020-2021 Office of Neighborhood Budget is adjusted to add \$95,000 to revenue and to add \$95,000 to expenditures.
