**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
FOR AUTHORIZATION TO ACCEPT AND APPROPRIATE THE CONTRA COSTA  
COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FUNDS IN  
AN AMOUNT NOT TO EXCEED \$250,000 FOR THE MARTIN LUTHER KING FIELD  
TURF REPLACEMENT PROJECT**

**WHEREAS**, the Contra Costa County (“CCC”) issued a Notice of Funding Availability (“NOFA”) in 2019 for the Fiscal Year 2020/21 Community Development Block Grant (“CDBG”) Program grant funds to benefit low income residents or communities of Contra Costa County; and

**WHEREAS**, the City of Richmond, a municipal corporation and a charter city, applied and was awarded the CDBG Program grant for the Martin Luther King field turf replacement project; and

**WHEREAS**, the City of Richmond has received and accepted the Agenda Report regarding this Resolution.

**NOW, THEREFORE, BE IT RESOLVED THAT**, the City Council of the City of Richmond finds the above recitals accurate and have served together with the Agenda Report as the basis for the findings and approvals set forth in this Resolution.

**BE IT FURTHER RESOLVED THAT**, the City of Richmond hereby agrees to use the CDBG Program funds for eligible activities in the manner presented in the application as approved by CCC and in accordance with CDBG Program Regulations.

**BE IT FURTHER RESOLVED THAT**, the City Council authorizes the City Manager or her designee to execute in the name of the City of Richmond, the Program Agreement, and all other documents required by CCC for participation in the CDBG Program, and any amendments thereto and accept and appropriate the grant funds.
