

**RESOLUTION NO. 66-20(A)**

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, TO  
APPROVE CONTRACT WITH POGO PARK TO RENOVATE AND EXPAND  
HARBOUR 8 PARK**

**WHEREAS**, Harbour 8 Park is City park located on the Richmond Greenway between Harbour Way and 8<sup>th</sup> Street; and

**WHEREAS**, Pogo Park is a local non-profit grass roots organization whose mission is "to transform lives by transforming public space" and "to re-claim and transform Richmond's unclaimed, under-utilized, and under-performing city parks into vibrant community spaces"; and

**WHEREAS**, Pogo Park works with the community at large to renovate and expand Harbour 8 Park; and

**WHEREAS**, Pogo Park partnered with the City of Richmond to submit an application for a Proposition 68 Grant to expand and renovate Harbour 8 Park; and

**WHEREAS**, the State awarded the City the \$8,500,000 through the Proposition 68 Grant to fund contracts for the Harbour 8 Park Expansion project; and

**WHEREAS**, the State awarded the City the Proposition 68 Grant largely due to Pogo Park's innovative community engagement, training and build activities and to support a community design and build model for Harbour 8 Park; and

**WHEREAS**, since the City was notified of the award, City staff and Pogo Park have worked collectively to determine how to move forward with this complex project in a manner that supports the community's vision for Harbour 8 Park by meeting grant requirements and time line; and

**WHEREAS**, the ongoing support of Pogo Park is critical to achieving the goals of the project; and

**NOW, THEREFORE**, that the Richmond City Council does resolve as follows:

The Council does hereby authorize the City Manager or his designee to execute a contract with Pogo Park in the amount of \$1,600,000 to provide design, community outreach, engagement and training, and project and contract administration.
