

RESOLUTION NO. 67-07

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, ADOPTING THE FISCAL YEAR 2007/08 THROUGH 2011/12 CAPITAL IMPROVEMENT PLAN AND FISCAL YEAR 2007-08 BUDGET FOR THE GENERAL CAPITAL IMPROVEMENT FUND, SPECIAL REVENUE FUNDS AND ENTERPRISE FUNDS.

WHEREAS, a balanced Annual Budget for the City of Richmond has been prepared for Fiscal Year 2007 - 2008 and presented to City Council pursuant to Article IV, Section 1 (B) for the Charter of the City of Richmond;

WHEREAS, all appropriations for the prior fiscal years shall lapse at the end of Fiscal year 2007 - 2008 and any remaining amounts shall be credited against their respective fund balances, except for:

- a. Any unexpected but encumbered amounts for specific orders outstanding at the end of the Fiscal Year; and
- b. Any appropriations for incomplete capital projects including the Municipal Sewer District at the end of Fiscal Year 2006-2007.

WHEREAS, the City Council approves the following transfers to fund Fiscal Year 2007-08 Capital needs:

- a. Drawdown and transfer all available funds to the General Capital Fund, which amounts to \$4,253,434 from the Pension Stabilization Fund, pursuant to Section 4.05 of the Trust Indenture for the Taxable Pension Funding Bonds, Series 2005.
- b. Project expenditures in the amount of \$203,932,185 for the first year (FY2007-08) of the Plan.

For these exceptions and transfers, such carry-overs may be made without any further City Council action.

NOW THEREFORE, BE IT RESOLVED that the City Manager is hereby directed to place appropriations and estimated revenues in effect on **July 1, 2007** and as shown in the FY 2007-2008 Capital Improvement Budget.
