

RESOLUTION NO. 156-21

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, TO AMEND THE POSITION CONTROL LIST FOR THE WATER
RESOURCE RECOVERY DIVISION OF THE PUBLIC WORKS DEPARTMENT**

WHEREAS, the City’s National Pollutant Discharge Elimination System (N.P.D.E.S.) Permit requires the City to implement and enforce its approved pretreatment programs in accordance with federal pretreatment regulations (40 C.F.R. part 403); and

WHEREAS, in order to enforce these requirements, the City is required to have adequate pretreatment staff; and

WHEREAS, on June 29, 2021, City Council adopted FY 2021-22 budget via Resolution 77-21; and

WHEREAS, the Water Resource Recovery Division of the Public Works Department allocated that three (3) Environmental Compliance Inspectors, one Senior Environmental Compliance Inspector, and one (1) Environmental Services Manager positions are to be funded from the Pretreatment Program Budget; and

WHEREAS, the Position Control Listing that was adopted as part of the FY 2021-22 Budget for the Water Resource Recovery Division of the Public Works Department only listed two (2) Environmental Compliance Inspectors, one (1) Senior Environmental Compliance Inspector, and one (1) Environmental Services Manager positions; and

WHEREAS, the Position Control List needs to be amended to reflect what is reflected in the FY 2021-22 budget and to ensure that the City remains in compliance with Chapter 40 of the Code of Federal Regulations Part 403 “Protection of the Environment” as it applies to the City’s N.P.D.E.S. Permit.

NOW, THEREFORE, BE IT RESOLVED that the Position Control List for the Water Resource Recovery Division of the Public Works Division is hereby revised and amended to add one (1) additional Environmental Control Inspector for a Division total of three (3) Environmental Compliance Inspectors, one (1) Senior Environmental Compliance Inspector, and one (1) Environmental Services Manager.


