

RESOLUTION NO. 31-22

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
AUTHORIZING THE THIRD AMENDMENT TO NCE ON-CALL PROFESSIONAL
SERVICES CONTRACT TO INCREASE THE CONTRACT NOT-TO-EXCEED
AMOUNT BY \$2,060,000 TO A TOTAL OF \$3,860,000 FOR THE REMAINDER OF
THE FIVE-YEAR CONTRACT**

WHEREAS, the Richmond Public Works Department has numerous capital improvement projects funded by Federal and State Grants, Measure J Funds, and Wastewater Bonds that require the use of On-Call Professional Services; and

WHEREAS, on May 18, 2018, NCE (Richmond Engineering Consultant Company) was one of the five On-Call Professional Services consultants selected for a three-year contract with an option for two additional years; and

WHEREAS, NCE is the Designer of Record of several multi-year design development and Capital Improvement Program projects; and

WHEREAS, some of these projects are already in construction and still require NCE construction support; and

WHEREAS, other projects are in the middle of their project development processes that require additional NCE Professional Services to get the projects to completion; and

WHEREAS, NCE current funding allocation is nearly depleted to continue delivering the projects on schedule; and

WHEREAS, staff is now seeking Council approval to increase by \$2,060,000 the amount of NCE Service Contract for a total not-to-exceed amount of \$3,860,000, and to add to the scope of services for the remainder of the NCE contract as shown on *Exhibit I*; and

WHEREAS, the Richmond Public Works Department will continue to efficiently manage the NCE contract, as amended.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Richmond, California, hereby authorizes the Richmond Public Works Department to amend the NCE contract by \$2,060,000 to an amount not to exceed \$3,860,000.
