

RESOLUTION NO. 91-22

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
APPROVING THE FISCAL YEARS 2022-23 THROUGH 2026-27 CAPITAL
IMPROVEMENT PLAN AND ADOPTING THE FISCAL YEAR 2022-23 BUDGET FOR
THE CAPITAL IMPROVEMENT FUNDS**

WHEREAS, a balanced Budget for the City of Richmond has been prepared for Fiscal Year 2021-22 and presented to the City Council pursuant to Article IV, Section 1 (b) of the Charter of the City of Richmond; and

WHEREAS, a Capital Improvement Plan for Fiscal Years 2022-23 through 2026-27 has been prepared; and

WHEREAS, the budget for the Capital Improvement Funds for the 2022-23 Fiscal Year has been prepared; and

WHEREAS, all appropriations for the prior fiscal year shall lapse at the end of Fiscal Year 2021-22 and any remaining amounts shall be credited against their respective fund balances, except for:

- a. Any unexpected but encumbered amounts or specific orders outstanding at the end of the Fiscal Year; and
- b. Any appropriations for incomplete capital projects including the Municipal Sewer District at the end of Fiscal Year 2021-22; and

WHEREAS, for these exceptions, such carry-overs may be made without any further City Council action; and

WHEREAS, the City Council needs to approve the following expenditures for the Fiscal Year 2022-23 Capital Improvement budget:

- a. Project expenditures in the amount of \$37,256,854 for the Fiscal Year FY2022-23 of the Capital Improvement Plan.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Richmond hereby (1) approves the Capital Improvement Plan for Fiscal Years 2022-23 through 2026-27; (2) adopts the budget for the Capital Improvement Funds for the 2022-23 Fiscal Year; and (3) authorizes the City Manager to place appropriations and estimated revenues in effect on July 1, 2022, and as shown in the FY2022-23 Capital Improvement Budget.
