**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
ACCEPTING AND APPROPRIATING THE URBAN FLOOD PROTECTION GRANT
AWARD OF \$1,598,844 FOR THE FLOOD RISK REDUCTION IN THE RHEEM CREEK
WATERSHED PROJECT**

WHEREAS, the City of Richmond (City) collaborated with American Rivers, The Watershed Project, and Restoration Design Group to apply to the California Natural Resources Agency Urban Flood Protection Grant Program for the Flood Risk Reduction in the Rheem Creek Watershed Project; and

WHEREAS, on July 6, 2021, the Richmond City Council adopted Resolution No. 83-21, approving the application for grant funds for the Urban Flood Protection Grant and authorizing the City Manager, or their designee, to execute agreements with project partners to complete the grant-funded project; and

WHEREAS, on September 7, 2021, the California Natural Resources Agency awarded the City of Richmond \$1,598,844 for the Flood Risk Reduction in the Rheem Creek Watershed Project; and

WHEREAS, the Flood Risk Reduction in the Rheem Creek Watershed Project will rehabilitate a 2,000-foot section of Rheem Creek and will reduce flooding in the surrounding neighborhood.

NOW, THEREFORE, BE IT RESOLVED that the City Council finds the above recitals are true and correct and have served as the basis for the findings and approvals set forth in this Resolution.

BE IT FURTHER RESOLVED that the City Council hereby authorizes the City Manager, or their designee, to accept and appropriate the grant funds in the amount of \$1,598,844 for Fiscal Year 2022-23.

BE IT FURTHER RESOLVED that the City hereby agrees to allocate the grant funds for a multi-benefit project to address flooding in urbanized areas in accordance with the Urban Flood Protection Grant Program Application Guidelines and the State of California Natural Resources Agency Grant Agreement #UF8814-0.

BE IT FURTHER RESOLVED that this resolution takes effect immediately upon its passage.
