**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, FOR AUTHORIZATION TO ACCEPT AND APPROPRIATE THE  
CALIFORNIA DEPARTMENT OF PARKS AND RECREATION OUTDOOR EQUITY  
GRANT PROGRAM FUNDS IN AN AMOUNT NOT TO EXCEED \$700,000 FOR THE  
YOUTH OUTDOORS RICHMOND PROGRAM**

**WHEREAS**, the State of California Department of Parks and Recreation (“State”) requested proposals (“NOFA”) on June 1, 2021, for the California Department of Parks and Recreation Outdoor Equity Grant funds to benefit low-income residents or communities of California; and

**WHEREAS**, the City of Richmond, as a municipal corporation and a charter city, applied and was awarded the Outdoor Equity Grant for the Youth Outdoors Richmond program; and

**WHEREAS**, the City of Richmond has received and accepted the Agenda Report regarding this Resolution.

**NOW, THEREFORE, BE IT RESOLVED THAT** the City Council of the City of Richmond finds the above recitals accurate and have served together with the Agenda Report as the basis for the findings and approvals set forth in this Resolution.

**BE IT FURTHER RESOLVED THAT** the City of Richmond hereby agrees to use the Outdoor Equity Grant funds for eligible activities in the manner presented in the application as approved by the State and in accordance with Program Regulations.

**BE IT FURTHER RESOLVED THAT** the City Council authorizes the City Manager or their designee to execute in the name of the City of Richmond, the Grant Agreement, and all other documents required by the State for participation in the Outdoor Equity Grant Program, and any amendments thereto and accept and appropriate the grant funds.
