

**RESOLUTION NO. 46-23**

**A RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
ADOPTING THE FISCAL YEAR 2022-23 QUARTER 3 BUDGET AMENDMENTS**

**WHEREAS**, pursuant to Section 1(b) of Article IV of the Richmond City Charter the City Manager is required to prepare an annual budget for the review and approval by the City Council; and

**WHEREAS**, the City’s budget was originally adopted on June 21, 2022; and

**WHEREAS**, the City’s quarter 1 budget report was received on December 6, 2022, to monitor budget to actual trends between the time period of July 1, 2022, and September 30, 2022; and

**WHEREAS**, the City’s mid-year budget report was received on March 28, 2023, to monitor budget to actual trends between the time period of July 1, 2022, and December 31, 2022; and

**WHEREAS**, the City’s quarter 3 budget report was received on May 16, 2023, to monitor budget to actual trends between the time period of July 1, 2022, and March 31, 2023; and

**WHEREAS**, the City Council has reviewed the proposed budget adjustments in the quarter three budget report; and at a public meeting on May 16, 2023; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Council of the City of Richmond, California hereby adopts the resolution to receive the City’s quarter 3 budget report and approve the proposed budget amendments set forth in Table 1, below:
