NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the **ZONING ADMINISTRATOR** of the City of Richmond will conduct a virtual public hearing to consider the following project:

PROJECT NO: PLN23-384
PROJECT NAME: Collin Front Yard Fence
PROJECT ADDRESS: 3325 Florida Avenue

APPLICANT: Same as property owner
PROPERTY OWNER: Francisco Collin

DESCRIPTION: The project applicant built a fence along the front and side yard property lines without obtaining a fence permit from the City. The applicant has submitted a Fence Height Exception application to modify the unpermitted fence so that it complies with the City's fence ordinance. The modified fence would incorporate a four-foot-high solid wood fence with a two-foot-high semi-transparent wood lattice (for a total fence height of six-feet).

This meeting was originally scheduled for March 14, 2024, but that meeting was cancelled due to technical difficulties with the Zoom Video/Teleconferencing app.
