DESCRIPTION:	On September 14, 2023, the City's Design Review Board approved a Design Review Permit to construct a new two-story duplex on the ±4,300-square-foot vacant parcel, subject to issuance of an Administrative Use Permit (AUP) which would allow off-street parking to occur within the 40-foot parking setback. At this meeting, the City's Zoning Administrator will consider granting the AUP for the project.
