

RESOLUTION NO. 122-07

RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, LEVYING SPECIAL ASSESSMENT FOR UNPAID WASTE COLLECTION SERVICE CHARGES ON CERTAIN LANDS SITUATED IN THE CITY OF RICHMOND, COUNTY OF CONTRA COSTA, STATE OF CALIFORNIA:

WHEREAS, pursuant to Richmond Municipal Code (RMC), Chapter 9.20, Section 9.20.100(b) subscription to garbage collection service for all premises is required in the City of Richmond, and

WHEREAS, the premises located in the City of Richmond, County of Contra Costa, State of California, and described in Exhibit A attached hereto and by this reference incorporated herein, were provided with waste collection service as required by RMC, Chapter 9.20; and

WHEREAS, pursuant to the provisions of Section 9.20.110, the owners of said premises were notified in writing of their requirement to subscribe for garbage collection services and make payments as required by said Code Section; and

WHEREAS, said owners of the premises failed to make payments for waste collection services as required; and

WHEREAS, as a result, the City of Richmond has incurred charges for delinquent waste collection charges and administrative costs, which amounts remain unpaid; and

WHEREAS, said delinquent waste collection service charges and administrative costs are enumerated in Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that pursuant to Section 9.20.110 of the Municipal Code of the City of Richmond, the City Council of the City of Richmond does hereby lien and levy a special assessment against each premises, in the amounts as identified for each specific premise list in the Exhibit A which is attached hereto and incorporated herein, by this reference.

BE IT FURTHER RESOLVED that Exhibit A may be amended to delete any enumerated waste collection service charges and administrative costs paid before special assessments authorized hereby are forwarded to the County Recorder of Contra Costa County, California.

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to record this resolution, together with Exhibit A as may be amended, with the Office of the County Recorder of Contra Costa County, California.

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to deliver a copy of this resolution to the Director of Finance of the City of Richmond, and that Director of Finance is authorized to cause the above amounts to be collected in the manner provided by law for collection of special assessments.
