

RESOLUTION NO. 36-08

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND
DESIGNATING AND APPOINTING STANDBY OFFICERS FOR THE
MEMBERS OF THE CITY COUNCIL**

WHEREAS, Article 15 of the State of California Emergency Services Act (California Government Code Sections 8635 et seq.), dated February 1983, provides for the preservation of local government in the event of an enemy attack, state of emergency or local emergency; and

WHEREAS, said Article requires that the governing body of a political subdivision appoint three standby officers for each member of the governing body; and

WHEREAS, those standby officers shall be designated Numbers 1, 2 and 3, and shall be appointed and serve as council members in that order, as provided for pursuant to the provisions of Article 15 of the State of California Services Act of 1983.

NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Richmond designates and appoints the following standby officers at the pleasure of the City Council until removal or replacement of said designated standby officers, as may be warranted.
