

RESOLUTION NO. 155-25

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
APPROVING THE USE OF OMNIA PARTNERS PIGGYBACK PURCHASE
AGREEMENTS WITH UKG KRONOS SOLUTIONS, LLC IN AN AMOUNT NOT TO
EXCEED \$60,000 FOR A TERM BEGINNING NOVEMBER 5, 2025, THROUGH
NOVEMBER 4, 2028, WITH TWO ONE-YEAR OPTIONS TO EXTEND**

WHEREAS, the Richmond Fire Department uses Telestaff, a product of UKG Kronos Solutions, LLC, for its payroll, staffing, and personnel management; and

WHEREAS, the software requires an annual maintenance agreement renewal in order to receive upgrades and continued web portal support; and

WHEREAS, the current version of the software used by the Department will soon reach the end of its engineering support and must be upgraded to the latest version; and

WHEREAS, operating the system without the appropriate software and licenses would render the program obsolete, potentially requiring the purchase of a new system at considerable cost; and

WHEREAS, the use of Piggyback Purchase Agreements to renew and upgrade the annual maintenance agreements with the vendor maximizes cost savings and more effectively utilizes staff resources by relying on existing contracting and procurement efforts established in collaboration with other government agencies; and

WHEREAS, the use of Piggyback Purchase Agreements through OMNIA Partners, a leading national government purchasing piggyback, will provide the best overall supplier government pricing; and

WHEREAS, the recommendations in this report are in accordance with Section 2.52.330 of the City Municipal Code; and

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Richmond:

1. The City of Richmond approves the use of OMNIA Partners Piggyback Purchasing Agreements with UKG Kronos Solutions, LLC, in an amount not to exceed \$60,000, for a three-year term effective November 5, 2025, through November 4, 2028, with a two one-year extension option not to exceed an additional \$40,000 for the extended term, as listed in the OMNIA Partners Piggyback Contract list below:
