

RESOLUTION NO. 176-25

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN
AMENDMENT WITH GOLDEN BEAR TRANSFER SERVICES, INC TO EXTEND
THE AGREEMENT FOR TEN (10) YEARS
THROUGH DECEMBER 31, 2035**

WHEREAS, the City and GBTS entered into an exclusive franchise agreement entitled “Exclusive Franchise Agreement Between City of Richmond and Golden Bear Transfer Services, Inc. (“GBTS”) effective June 28, 2004, through December 31, 2025 (“GBTS Franchise Agreement”); and

WHEREAS, pursuant to Section 3 of the GBTS Franchise Agreement, the contractor, Golden Bear Transfer Services, Inc., provided notice to the City exercising its right to extend the term of the agreement more than 180 days prior to the expiration of the Agreement; and

WHEREAS, pursuant to Section 3 of the GBTS Franchise Agreement, the term extension shall be for 10 years through and including December 31, 2035; and

WHEREAS, all of the terms, conditions, rights and obligations of the parties under the GBTS Franchise Agreement shall remain in full force and effect and shall not be changed in any manner except as expressly set forth in this Amendment to the GBTS Franchise Agreement; and

WHEREAS, Article XI, section 7 of the Constitution of the State of California empowers the City to make and enforce within its limits all sanitary and other ordinances and regulations not in conflict with general laws for the management of solid waste generated within the City; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Richmond hereby approves the amendment to the Exclusive Franchise Agreement Between City of Richmond and Golden Bear Transfer Services, Inc. extending the term through and including December 31, 2035.
