

RESOLUTION NO. 13A-09

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA ACCEPTING REDEVELOPMENT FUNDS FOR CERTAIN PUBLIC IMPROVEMENTS TO NEVIN PARK, MAKING FINDINGS AND APPROVALS PURSUANT TO THE CALIFORNIA COMMUNITY REDEVELOPMENT LAW, AND AUTHORIZING A CONTRACT AMENDMENT WITH ADT SECURITY SERVICES INC. IN AN AMOUNT NOT TO EXCEED \$49,800 FOR CERTAIN PUBLIC IMPROVEMENTS TO NEVIN PARK

WHEREAS, the City Council of the City of Richmond (the "City Council") adopted the Amended and Restated Redevelopment Plan for Project Area No. 10-B (Nevin) adopted by Ordinance No. 29-05, dated July 12, 2005 the Amended and Restated Redevelopment Plan for Project Area No. 10-A (Downtown) adopted by Ordinance No. 29-99, dated July 13, 1999 (the "Redevelopment Plans"). The Redevelopment Plans set forth a plan for redevelopment of Project Area No. 10-A (Downtown) and 10-B (Nevin) (the "Project Areas"); and

WHEREAS, the Richmond Community Redevelopment Agency (the "Agency") is responsible for administering the Redevelopment Plan to cause the redevelopment of the Project Area, including installation of public improvements to public recreation areas consistent with the Redevelopment Plan; and

WHEREAS, it would be beneficial to public safety in the Project Area to make certain camera and related equipment installation public improvements to Nevin Park and the Agency desires to spend funds for the public improvements to Nevin Park pursuant to Health and Safety Code Section 33445 ("Public Improvements"); and

WHEREAS, the Implementation Plan adopted by the Agency specifically identifies the installation of public improvements as a potential project; and

WHEREAS, installation of the Public Improvements conforms with the General Plan of the City; and

WHEREAS, the Agency expenditures for the Public Improvements will assist in the redevelopment of the Project Area and the Public Improvements are necessary to effectuate the purpose of the Redevelopment Plan; and

WHEREAS, pursuant to Health and Safety Code Section 33445, the Agency may, with the consent of the City Council, pay part or all of the cost of the Public Improvements if the City Council makes certain specified findings; and

WHEREAS, a Notice of Exemption was duly filed on October 16, 2007 with the county clerk and the State of California; and

WHEREAS, by staff report accompanying this Resolution and incorporated into this Resolution by this reference (the "Staff Report"), the City Council has been provided with additional information upon which the findings and actions set forth in this Resolution are based; and

WHEREAS, the Agency budgeted the necessary funds to construct the Public Improvements and such funds are authorized in its approved FY 2008-2009 budget; and

WHEREAS, on July 31, 2007, after a competitive process, the City Council authorized the City Manager to negotiate and execute a three (3) year contract with ADT Security Services, Inc. (“ADT”) to design, install, implement, integrate, configure, maintain, and test a closed-circuit television surveillance system consisting of 34 cameras throughout City of Richmond police beats 1-7, and Unincorporated North Richmond. On November 27, 2007, the City and ADT entered into that certain CCTV Implementation Services Agreement between the City and ADT for such work (“City Agreement”); and

WHEREAS, the City now desires for ADT to perform, and the Agency desires to fund, certain new services for the Public Improvements in accordance with Section 2.7 of the City Agreement pursuant to ADT Quote #38, dated January 28, 2009, attached to the Staff Report.

NOW, THEREFORE, BE IT RESOLVED, that the Richmond City Council finds the above recitals are accurate.

BE IT FURTHER RESOLVED, that the City Council hereby finds and determines, pursuant to Health and Safety Code Section 33445, that: (a) the Public Improvements will be of benefit to the Project Area; (b) no other reasonable method of financing the Public Improvements is available to the community; (c) the Public Improvements will assist in the elimination of one or more blighting conditions inside the Project Area; and (d) the Agency assistance for the Public Improvements is consistent with the Agency's current Implementation Plan.

BE IT FURTHER RESOLVED, that the City Council hereby accepts \$49,800 from the Agency for construction of the Public Improvements, authorizes the First Amendment to the City Agreement in an amount not-to-exceed \$49,800, for construction of the Public Improvements and authorizes the City Manager to enter into such First Amendment.

BE IT FURTHER RESOLVED, that the City Council designates the City Clerk as the custodian of the documents and other material, including the Staff Report and Project Plans, which constitute the record of proceedings upon which the decision herein is based. These documents may be found at the office of the City Clerk at the Richmond City Hall, 1401 Marina Way South, Richmond, California 94804.

BE IT FURTHER RESOLVED, that this Resolution shall take immediate effect from and after its passage.
