**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS
AWARDED TO THE RICHMOND PUBLIC LIBRARY'S LITERACY FOR EVERY
ADULT PROGRAM (LEAP) BY THE CALIFORNIA STATE LIBRARY THROUGH
THE CALIFORNIA LIBRARY LITERACY SERVICES (CLLS) PROGRAM AND
AMENDING LEAP'S FY2009/2010 STATE GRANT BUDGET NOT TO EXCEED
\$112,237**

WHEREAS, the California State Library has awarded California Library Literacy Services funds in the amount of \$112,237 to the Richmond Public Library, Literacy for Every Adult Program (LEAP) ; and

WHEREAS, the California State Library Literacy Services funds are distributed by the California State Library annually to provide literacy services ; and

WHEREAS, the Literacy for Every Adult Program (LEAP) budget was adopted by City Council in June 2009 in the amount of \$82,995; and

WHEREAS, the LEAP budget is now being amended to reflect the increase of \$29,242 in additional revenue and expenditure appropriations funded through the CLLS grant resulting in a total state grant budget of \$112,237 for FY2009/2010 to be allocated per Library staff recommendations.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Richmond that the Richmond Public Library, Literacy for Every Adult Program (LEAP) will accept the FY2009/2010 CLLS award of \$112,237 and LEAP's state grant budget is approved to increase by \$29,242 resulting in a total FY2009/2010 LEAP state grant budget of \$112,237 to be appropriated toward funding literacy services.
