**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND,

AND ACCEPTANCE OF A GRANT IN THE AMOUNT OF \$4,700.00 FROM THE  
NORTHERN CALIFORNIA GRANT MAKERS (UCG) – SUMMER YOUTH  
PROJECT.**

WHEREAS, the City of Richmond Library and Community Services Department – Recreation Division partnered with the Northern California Grant Makers – Summer Youth Program in 1978 to provide funding to expand youth/teen summer program opportunities at the community centers and other program units to include excursions, additional program supplies, and amusement park admissions; and

WHEREAS, the Library and Community Services – Recreation Division has been successful in developing positive outlets for youth so as to be awarded \$4,700.00.00 from the Northern California Grant Makers – Summer Youth Project for Recreation Summer Camps.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Richmond that the Library and Community Services Department, Community Services Program Manager, is authorized to accept this \$4,700.00 grant (1000-10057-4407) and seek additional financial support;

BE IT FURTHER RESOLVED that the Library and Community Services Department Recreation Division staff will comply with all requirements including the submission of a final report detailing all program grant activity and other information requested by the Northern California Grant Makers – Summer Youth Program; and

BE IT FURTHER RESOLVED that the Northern California Grant Makers – Summer Youth Program may use the “City of Richmond Library and Community Services Department – Recreation Division” name in recognition of unique programs offered during the summer.
