

**RESOLUTION NO. 8 -10**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND  
AUTHORIZING THE ACCEPTANCE OF A STATE OF CALIFORNIA  
TRANSPORTATION DEVELOPMENT ACT ARTICLE 3 GRANT AND  
EXPENDITURE OF GRANT FUNDS FOR THE PURPOSE OF DEVELOPING A  
CITYWIDE BICYCLE PLAN.**

**WHEREAS**, Article 3 of the Transportation Development Act (TDA), Public Utilities Code (PUC) Section 99200 et seq. authorizes the submission of claims to a regional transportation planning agency for the funding of projects exclusively for the benefit and/or use of pedestrians and/or bicyclists; and

**WHEREAS**, the Metropolitan Transportation Commission (MTC), as the regional transportation planning agency for the San Francisco Bay Region, has adopted MTC Resolution No. 875, Revised entitled “Transportation Development Act, Article 3, Pedestrian/Bicycle Projects,” which delineates procedures and criteria for submission of requests for the allocation of “TDA Article 3” funding; and

**WHEREAS**, by Resolution 126-08, the City Council authorized application for allocation of TDA Article 3 funding; and

**WHEREAS**, the City of Richmond’s application was accepted and MTC Resolution 3620 authorizes disbursement of funds in the amount of \$100,000 to be applied for the purpose of developing a master bicycle plan, and

**WHEREAS**, the City of Richmond desires to access those TDA Article 3 funds granted to the City for the purpose of developing said Bicycle Master Plan for the benefit of bicycle riders in the City of Richmond.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Richmond hereby authorizes the City Manager of the City of Richmond, or his or her designee, to accept \$100,000 in State of California Transportation Development Act (TDA) Article 3 funds from the Metropolitan Transportation Commission and to spend those funds for the purpose of supporting the development of a Bicycle Master Plan.
