

**RESOLUTION NO. 27-10**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, NAMING THE MARINA BAY UNDERPASS IN HONOR OF FALLEN RICHMOND POLICE OFFICER BRADLEY A. MOODY**

**WHEREAS**, Bradley A. Moody joined the Richmond Police Department in 2000; and

**WHEREAS**, Officer Moody was a K-9 officer and served the City of Richmond and its citizens with distinction for eight years; and

**WHEREAS**, on October 4, 2008, Officer Bradley Moody was fatally injured in a collision on the Marina Bay Parkway when he was en route to answer an urgent call of duty; and

**WHEREAS**, Officer Moody was held in the highest regard by his peers and the community in which he served; and

**WHEREAS**, Richmond Police Chief Chris Magnus determined that Officer Moody should be remembered through memorial signage near the site of his fatal collision, and directed Sergeant Tod Opdyke to seek approval of such signage; and

**WHEREAS**, the Marina Bay Neighborhood Council and the Richmond Redevelopment Agency’s underpass design team have both approved recommending that the Marina Bay Parkway underpass be named the “Officer Bradley A. Moody Memorial Underpass”; and

**WHEREAS**, the Recreation & Parks Commission, which is charged with recommending the name of city facilities to the City Council, at their regular meeting in January 2010 unanimously recommended that the City Council “name the project under development the Officer Bradley A. Moody Memorial Underpass”;

**NOW THEREFORE, BE IT RESOLVED** that the Richmond City Council hereby dedicates the Marina Bay Parkway underpass in the memory of Officer Moody, and directs that the underpass be named the “Officer Bradley A. Moody Memorial Underpass”; and

**BE IT FURTHER RESOLVED** that the City Council directs the Clerk to promptly forward a copy of this Resolution to the clerk of the Contra Costa Board of Supervisors and to the Contra Costa County Surveyor.
