**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA
SUPPORTING A PARTNERSHIP BETWEEN THE CITY AND CYBERTRAN
INTERNATIONAL, INC.**

WHEREAS, the City of Richmond and CyberTran International, Inc. have partnered in support of an Ultra Light Rail Transit (ULRT) system to consistent to meet the City's policies and objectives of improving public transportation throughout the City and Bay Area region;

WHEREAS, the development of a ULRT system would improve the City's existing infrastructure and facilities needed for the movement of people and vehicles throughout the city;

WHEREAS, a ULRT system would improve the City's economic health and quality of life, and provide for the mobility of people and performance that affects concerns like air quality, environmental resource consumption, social equity, land use, urban growth, economic development, and safety;

WHEREAS, the City of Richmond and CyberTran International, Inc. have partnered to ensure the Richmond community transit needs are met and that the City of Richmond General Plan Land Use and Circulation policies, goals and implementation measures provide accessibility and mobility for Richmond residents through a ULRT system;

WHEREAS, a ULRT system would create manufacturing job opportunities and expand neighborhood transportation services and programs throughout the City and support regional transportation goals;

WHEREAS, CyberTran International Inc., is a company located in the United States that uses smart growth/transit-oriented development techniques.

WHEREAS, CyberTran's ultimate vision is to create a national and global sustainable transportation system throughout the region to resolve issues associated with fuel-burning technologies

NOW, THEREFORE, BE IT RESOLVED, that the City of Richmond and CyberTran International, Inc. have partnered to implement transportation mobility goal for transit-dependent individuals.
