

**RESOLUTION NO. 33-12**

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
AUTHORIZING THE ACCEPTANCE OF FUNDS ALLOCATED TO THE CITY  
FROM CONTRA COSTA COUNTY HEALTH SERVICES IN SUPPORT OF ITS  
HAZARDOUS MATERIALS DIVISION**

**WHEREAS**, the Contra Costa County has appropriated monies for the Hazardous Material Response Unit Program under Agreement #22-351-15, approved by the Board of Supervisors on April 28, 1987; and

**WHEREAS**, the Contra Costa County Health Services Hazardous Materials Division will allocate funding to the City of Richmond Fire Department from July 1, 2011, through June 30, 2012, in an amount not to exceed \$156,387; and from July 1, 2012, through June 30, 2013, in an amount not to exceed \$156,388, who will maintain a Hazardous Materials Response Unit in West County; and

**WHEREAS**, the City of Richmond Fire Department shall be awarded \$312,775 over a two-year period, commencing July 1, 2011, for projected expenditures through June 30, 2013; and

**WHEREAS**, the City of Richmond desires to accept the funds allocated by the Contra Costa County Health Services Hazardous Materials Division in the amount of \$312,775.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Richmond that:

- The City of Richmond shall accept the allocation of \$312,775 from the Contra Costa County Health Services Hazardous Materials Division.
- The funds which the City will receive are hereby appropriated towards program expenditures, under Fund 1013, Org 11305022, Obj 400803.
- The City Manager, or his designee, shall establish a Budget Supplemental Fund revenue account under Fund 1013, Org 11305022, Obj 337371 for the deposit of the funds, which have been allocated to the City of Richmond.
- The Finance Director of the City of Richmond shall submit the necessary reports and summaries which are required by State law.
