

RESOLUTION NO. 62-12

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND APPROVING A CONTRACT WITH MP NEXLEVEL OF CALIFORNIA, INC FOR \$2,993,258.54 TO CONSTRUCT THE CITY OF RICHMOND MUNICIPAL NETWORK – SECURITY AND FIRST RESPONDERS PROJECT

WHEREAS, in September 2009, the United States of America Department of Homeland Security Awarded the Port Department of the City of Richmond (“Port”) a grant in the amount of \$4,310,504.00 for design and construction of a system that interconnects critical City facilities with an Ethernet network operating at a maximum bit rate of 10 gigabits per second (Gb/s) (the “Municipal Network Project” or “Project”);

WHEREAS, the Port, Information Technology, Engineering and Public Works designed the Municipal Network Project to integrate, surveillance, security, and communications between inner harbor terminals and first responders;

WHEREAS, following a public bid process, the Port selected MP Nexlevel of California, Inc as the lowest, responsive, and responsible bidder;

WHEREAS, the construction contract (the “Contract”) with MP Nexlevel of California, Inc will be for a not-to-exceed amount of \$2,993,258.54, which is less than the grant received;

WHEREAS, the Agenda Report provided to the City Council includes additional information upon which the findings and actions set forth in this Resolution are based.

NOW, THEREFORE, BE IT RESOLVED, that the City Council hereby finds the above recitals are true and correct and have served, together with the Agenda Report, as the basis for the findings and actions set forth in this Resolution.

NOW, THEREFORE, BE IT FURTHER RESOLVED, the City Council hereby approves and authorizes the City Manager to execute the Contract with MP Nexlevel of California, Inc in an amount not-to-exceed \$2,993,258.54.
