

RESOLUTION NO. 102-12

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$28,627 IN FUNDS AWARDED TO THE CITY OF RICHMOND THROUGH THE UNIVERSITY OF CALIFORNIA BERKELEY, SAFE TRANSPORTATION RESEARCH AND EDUCATION CENTER, SOBRIETY CHECKPOINT MINI-GRANT PROGRAM

WHEREAS, the Regents of the University of California, Berkeley, School of Public Health have received funding from the State of California Office of Traffic Safety;

WHEREAS, the funds received by the University of California, Berkeley, are administered by the University of California, Berkeley, Safe Transportation Research and Education Center; and

WHEREAS, the Safe Transportation Research and Education Center has a traffic checkpoint program for local law enforcement agencies; and

WHEREAS, the traffic checkpoint program for local law enforcement agencies has the goal of reducing the number of victims killed and injured in alcohol involved traffic collisions in participating agencies; and

WHEREAS, the City of Richmond has applied to conduct a minimum of three (3) sobriety checkpoints during the period between December 16, 2011 and September 3, 2012, and to receive reimbursement for the actual cost of overtime salaries paid for each checkpoint in an amount not to exceed the approved maximum allowable cost of \$6,750 per checkpoint; and

WHEREAS, the City of Richmond has applied to receive reimbursement for the cost of supplies related to the administration and operation of the checkpoints in an amount not to exceed the approved maximum allowable cost of \$8,377; and

WHEREAS, the City of Richmond is one of those cities which applied to participate in the Sobriety Checkpoint Program and has been awarded funding of \$28,627 by the Safe Transportation Research and Education Center to conduct sobriety checkpoints between December 16, 2011 and September 3, 2012; and

WHEREAS, the City of Richmond has agreed to comply with the grant objectives set forth in the grant agreement with Regents of the University of California, Berkeley, School of Public Health.

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Richmond that:

1. The City of Richmond shall accept the reimbursement-type grant of \$28,627 from the Regents of the University of California, Berkeley, School of Public Health.
2. The Finance Director of the City of Richmond shall submit the necessary reports and summaries which are required by state law.
