

**RESOLUTION NO. 117-12**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND  
ACCEPTING AND APPROVING THE USE OF GRANT FUNDS FROM THE CLARA-  
BELLE HAMILTON TRUST AND THE CALIFORNIA RELEAF 2012-13 URBAN  
FORESTRY AND EDUCATION GRANT PROGRAM**

**WHEREAS**, the City of Richmond has received grants from the Clara-Belle Hamilton Trust and California ReLeaf 2012-13 Urban Forestry and Education Grant Program with specific instructions on how funds are to be used; and

**WHEREAS**, the City of Richmond has received a grant in the amount of Eighty-Three Thousand Four Hundred Thirty-Nine Dollars and Forty-One cents (\$83,439.41) from the Clara-Belle Hamilton Trust; and

**WHEREAS**, the Clara-Belle Hamilton Trust requires the City of Richmond to spend the funds to (1) supplement the sponsoring of public cultural programs of the Seaver Gallery of the Richmond Museum Association, Inc; (2) supplement the planning, development and payment of expenses for maintaining new open spaces and public parks; (3) supplement the current funds dedicated to preserving existing open spaces and public parks; and (4) supplement the renovation, furnishing and maintenance of the Seaver Gallery of the Richmond Museum Association, Inc.; and

**WHEREAS**, the City of Richmond has received a grant in the amount of Nine Thousand Nine Hundred Four Dollars and Eighty-Nine cents (\$9,904.89) from the California ReLeaf 2012-13 Urban Forestry and Education Grant Program; and

**WHEREAS**, the California ReLeaf 2012-13 Urban Forestry and Education Grant Program requires the City of Richmond to use the grant funds received to enable the City of Richmond Parks and Landscaping Division to add trees and plants in Richmond parks.

**NOW, THEREFORE, BE IT RESOLVED**, that the Council of the City of Richmond hereby accepts, the grant received from the Clara-Belle Hamilton Trust and appropriates the grant funds as follows:

- (1) Twenty Thousand Eight Hundred Fifty-Nine Dollars and Eighty-Seven cents (\$20,859.87) to supplement the sponsoring of public cultural programs of the Seaver Gallery of the Richmond Museum Association, Inc;
- (2) Twenty Thousand Eight Hundred Fifty-Nine Dollars and Eighty-Seven cents (\$20,859.87) to supplement the planning, development and payment of expenses for maintaining new open spaces and public parks;
- (3) Twenty Thousand Eight Hundred Fifty-Nine Dollars and Eighty-Seven cents (\$20,859.87) to supplement the current funds dedicated to preserving existing open spaces and public parks; and
- (4) Twenty Thousand Eight Hundred Fifty-Nine Dollars and Eighty cents to supplement the renovation, furnishing and maintenance of the Seaver Gallery of the Richmond Museum Association, Inc.

**BE IT FURTHER RESOLVED**, that the Council of the City of Richmond hereby accepts the grant received from the California ReLeaf 2012-13 Urban Forestry and Education Grant Program and appropriates the full Nine Thousand Nine Hundred Four Dollars and Eighty-Nine cents (\$9,904.89) to enable the City of Richmond Parks and Landscaping Division to add trees and plants in Richmond parks.
