

**RESOLUTION NO. 124-12**

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF REIMBURSEMENT OF EQUIPMENT COSTS ASSOCIATED WITH WEST CONTRA COSTA COUNTY URBAN SEARCH AND RESCUE PROGRAM FROM THE COUNTY OF CONTRA COSTA OFFICE OF THE SHERIFF STATE HOMELAND SECURITY GRANT**

WHEREAS, the City of Richmond Fire Department applied to the County of Contra Costa Office of the Sheriff to provide funding in the amount of \$178,000, through the California Emergency Management Agency FY10 Homeland Security Grant Program for the required tools, equipment and supplies necessary to implement the Urban Search and Rescue (USAR) training curriculum, and

WHEREAS, funding has been approved and the City of Richmond would like to enter into agreement with Contra Costa Office of the Sheriff, which would allow reimbursement of the cost for pre-approved USAR tools, equipment and supplies, and

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Richmond that:

- The City of Richmond shall accept the reimbursement funds of \$178,000 from the County of Contra Costa Office of the Sheriff.
- The funds which the City will receive are hereby appropriated towards the purchase of the required tools, equipment and supplies necessary to implement the Urban Search and Rescue (USAR) training curriculum.
- The City Manager, or his designee, shall establish a Budget Supplemental Fund revenue account string for the deposit of the funds, and a corresponding expense account string for expenditures, which will be reimbursed to the City of Richmond.
- The Finance Director of the City of Richmond shall submit the necessary reports and summaries which are required by State law.
- The City Manager, or his designee, shall negotiate and execute all agreements necessary for the implementation of this Resolution.
