

RESOLUTION NO. 103-13

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND RENAMING WESTERN DRIVE NORTH OF INTERSTATE 580 TO STENMARK DRIVE

WHEREAS, printed notices entitled “NOTICE OF HEARING to rename Western Drive North of Interstate 580 to Stenmark Drive” were duly and regularly posted along the lines of said portion of said street to be renamed, at the time, in the form, manner and number, and in all respects as required by City of Richmond policy, as appears from the affidavit now on file in the office of the City Clerk of the City of Richmond; and

WHEREAS, at regular meeting of the City Council of the City of Richmond held on July 16, 2013, the City Council (the “Council”) adopted a Resolution stating it’s intention (“Resolution of Intention”) to rename Western Drive North of Interstate 580 to Stenmark Drive and setting a public hearing for all persons in or objecting to the proposed street name change for July 30, 2013 at 6:30 P. M. or as soon thereafter as practicable in the Richmond City Council Chambers; and

WHEREAS, not less than ten (10) days have elapsed since the date of passage of said Resolution of Intention; and

WHEREAS, the name change is exempt from review under the California Environmental Quality Act; and

WHEREAS, the Council has authority under California Government Code Section 34091.1 to adopt a resolution to rename an existing public street; and

WHEREAS, at the meeting of the City Council of the City of Richmond held on July 30, 2013, the hearing on matter of renaming Western Drive North of Interstate 580 to Stenmark Drive was held over until October 15, 2013; and

WHEREAS, such public hearing on the proposed street name change was duly held at such appointed date, time and place and the Council considered all comments made orally and in writing regarding the proposed name.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Richmond does hereby resolve as follows:

- (1) Pursuant to the authority vested in the City Council by California Government Code Section 34091.1, the City Council hereby changes the name of Western Drive North of Interstate 580 to Stenmark Drive; and
- (2) That the City Clerk and the Public Works Department are hereby directed to take whatever steps are required by law to notify the public of said name change, including providing any required notices, including to the Contra Costa County Board of Supervisors pursuant to California Government Code Section 34092, and to proceed to make physical improvements to the street that reflect the intent of this resolution.
