

RESOLUTION NO. 108-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, AUTHORIZING THE APPROPRIATION OF \$33,701 IN MATCHING FUNDS FOR THE ASSISTANCE TO FIREFIGHTER'S GRANT AWARDED TO THE CONTRA COSTA COUNTY FIRE PROTECTION DISTRICT FOR THE PURCHASE OF SELF CONTAINED BREATHING APPARATUS (SCBA) EQUIPMENT

WHEREAS, the Contra Costa County Fire Protection District was awarded a regional Assistance to Firefighter's Grant in the amount of \$1,814,474 for the purchase of Self Contained Breathing Apparatus (SCBA) Equipment; and

WHEREAS, the Federal grant share is 80% or \$1,451,579 and the Local Government share is 20% or \$362,895; and

WHEREAS, the City of Richmond desires to accept twenty-six complete SCBA's at a cost of \$5,717 per unit and seventeen SCBA voice amplifiers at a cost of \$350.00 per unit from the Contra Costa County Fire Protection District through the Assistance to Firefighter's Grant at a cost of \$154,592, plus 9% sales tax of \$13,913, for a total cost of \$168,505; and

WHEREAS, the City of Richmond is required to cost share and pay upfront costs of 20%, or \$33,701, for the SCBA equipment, to the Contra Costa County Fire Protection District;

WHEREAS, the funding is available in the Fire Department's Fiscal Year 2013–2014 General Fund budget.

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Richmond that approval of the 20% local match or \$33,701 from the Fire Department's Fiscal Year 2013–2014 General Fund budget is granted for twenty-six complete SCBAs and seventeen SCBA voice amplifiers.
