**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND
ACCEPTING COOPERATIVE AGREEMENT NO. 28W.01 FOR TRANSPORTATION
RELATED PROJECTS AS ESTABLISHED AND APPROVED BY THE WEST
CONTRA COSTA TRANSPORTATION AUTHORITY AND PARTICIPATING CITIES**

WHEREAS, Measure J provides for the continuation of the County's half-cent transportation sales tax for 25 years beyond the expiration date of 2009 (formerly Measure C – the original 1998 transportation sales tax measure);

WHEREAS, Contra Costa Transportation Authority's (CCTA's) West Contra Costa Transportation Advisory Committee (WCCTAC) approved an allocation of \$150,000 from Measure J, Program 28b to the City of Richmond for eligible project(s) identified in the Cooperative Agreement;

WHEREAS, Program 28b provides for programming of funds to projects or programs eligible under the provisions of the Act. Such projects may include: (1) Paratransit services; (2) the implementation of recommended transportation projects in a regional study or plan; (3) Bart improvements; (4) neighborhood traffic calming improvements; (5) Transportation/transit information in languages other than English; and/or (6) other eligible transportation investments.

WHEREAS, a Cooperative Agreement is needed for authorization and transfer of the funds; and

WHEREAS, the funds received are considered new, unbudgeted revenue and will be allocated to the City Manager's Office, Paratransit Division for improved transportation services;

NOW THEREFORE BE IT RESOLVED that the Richmond City Council authorizes the City Manager to execute Cooperative Agreement 28W.01 with the Contra Costa Transportation Authority and Participating Cities; and

BE IT FURTHER RESOLVED that funds received from the identified measure and program in the amount of \$150,000 will be accepted and appropriated into the City Manager's Office, Paratransit Division revenue account stream in the amount of \$150,000.
