

**RESOLUTION NO. 36-15**

**ESTABLISHING PARKING RESTRICTION FROM 6:00 A.M TO 12:00 A.M. SEVEN DAYS-A-WEEK PARKING ENFORCEMENT ALONG 23<sup>RD</sup> STREET BETWEEN BISSELL AVENUE AND MARICOPA AVENUE**

WHEREAS, 23rd Street contains 2 hour and 1 hour parking restrictions between Bissell Avenue and the north city limits at Costa Avenue and Maricopa.

WHEREAS, the current parking regulation under R.M.C 14.44.020 "One Hour Parking" and 14.44.030 "Two Hour Parking" do not contain parking restrictions for Sundays, holidays and after 6:00 P.M for Monday through Saturday in general.

WHEREAS, some merchants along 23rd Street with longer business hours beyond 6:00 P.M are impacted by no parking spaces turn over for their customers.

WHEREAS, the on-street parking spaces are often occupied by the motorists and the "For Sale" car owners that seemingly abuse the allowance of unrestricted parking during evening hours and weekends.

WHEREAS, staff proposes to implement restricted parking with time limits between 6:00 A.M and 12:00 A.M and the enforcement of every hour of every day for between Bissell Avenue and Maricopa Avenue to resolve the lack of parking spaces along 23<sup>rd</sup> Street.

WHEREAS, the parking enforcement between the hour of 6:00 A.M to 12:00 A.M, every day along the 23<sup>rd</sup> Street between Bissell Avenue and Maricopa Avenue shall effectively begin following the completion of regulatory signs erected by Public Works.

WHEREAS, the Police Department shall utilize staffing level as appropriate for enforcement of these new parking regulations along the 23<sup>rd</sup> Street between Bissell Avenue and Maricopa Avenue, and

WHEREAS, the locations included in the new parking regulations and rescission of applicable resolution for 23rd Street parking restriction are listed below:

23rd Street (2 Hour) - Bissell Avenue to Grant Avenue  
[Rescind 73-81; 3-87; 123-80 & Revise 7734]

23rd Street West side between Grant and 130' south (1 Hour)  
[Rescind 84-84]

23rd Street East side between Grant and Clinton (1 Hour)  
[Rescind 61-85]

23rd Street (2 Hour) - Grant Avenue to Maricopa Avenue  
[Rescind 73-81; 3-87; 123-80 & Revise 7734].

NOW, THEREFORE, BE IT RESOLVED, the on-street parking along the 23rd Street road segment listed above shall be regulated under the R.M.C Chapter 14.44 for applicable restrictions to be in effect every day from 6:00 A.M through 12:00 A.M.

BE IT FURTHER RESOLVED by the Council of the City of Richmond that the Public Works Director is hereby authorized to erect and maintain the parking restriction signs along 23rd Street between Bissell Avenue and Maricopa Avenue.
