

RESOLUTION NO. 119-06

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
AUTHORIZING THE ACCEPTANCE OF FUNDS AWARDED THE CITY THROUGH THE
STATE OF CALIFORNIA'S CITIZENS' OPTION FOR PUBLIC SAFETY (COPS) PROGRAM
AND THE JUVENILE JUSTICE CRIME PREVENTION ACT FOR SUPPLEMENTAL LAW
ENFORCEMENT SERVICES

WHEREAS, the State of California has appropriated monies for the Citizens' Option for Public Safety (COPS) program and for juvenile justice programs specified pursuant to the Juvenile Justice Crime Prevention Act (JJCPA); and

WHEREAS, the State Controller is required to allocate the COPS and JJCPA funds to each county that has established a Supplemental Law Enforcement Services Fund (SLESF); and

WHEREAS, the County of Contra Costa has established a Supplemental Law Enforcement Services Fund; and

WHEREAS, state law requires the County Auditor to allocate a certain percentage of the monies received from the State Controller to the cities within the county in accordance with the relative populations of the cities; and

WHEREAS, County Auditor has made the allocations for the 2006-2007 fiscal year; and

WHEREAS, under this allocation, the City of Richmond is entitled to the amount of \$201,387.00 for front line law enforcement purposes; and

WHEREAS, the State of California requires that the City Council hold a public meeting to consider the Police Chief's request for funding; and

WHEREAS, the Richmond Police Chief has submitted to the City Council a request that the funds, which the City will receive under the allocation, be used for overtime.

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Richmond that:

1. The City of Richmond shall accept the allocation of \$201,387.00 from the Supplemental Law Enforcement Services Fund (SLESF).
2. The funds which the City will receive are hereby appropriated towards sworn officer overtime costs, Account 50130.
3. The City Manager, or his designee, shall establish a Supplemental Frontline Fund account under account string 2330 11191 for the deposit of the funds which have been allocated to the City of Richmond from the SLESF.
4. The Finance Director of the City of Richmond shall submit the necessary reports and summaries which are required by state law.
