

**CITY COUNCIL RESOLUTION NO. 88-15**

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
AUTHORIZING THE ACCEPTANCE OF FUNDS ALLOCATED TO THE CITY OF  
RICHMOND FROM CONTRA COSTA COUNTY HEALTH SERVICES IN SUPPORT  
OF THE FIRE DEPARTMENT'S PRE-HOSPITAL EMERGENCY MEDICAL FIRST  
RESPONDER SERVICES**

**WHEREAS**, Contra Costa County Health Services Emergency Medical Services Division has appropriated monies through Measure H under Agreement #23-551-1, to support first responder Emergency Medical Services (EMS) through training, and the purchase of medical equipment, electronic patient-care data reporting (ePCR) services, and supplies for fire agencies; and

**WHEREAS**, the Contra Costa County Health Services Emergency Medical Services Division will allocate funding to the City of Richmond Fire Department from July 1, 2015, through June 30, 2016, in an amount not to exceed \$223,022, based on the provisions outlined in Agreement #23-551-1; and

**WHEREAS**, the City of Richmond Fire Department shall be awarded \$223,022, commencing July 1, 2015, for projected services and expenditures through June 30, 2016; and

**WHEREAS**, the City of Richmond desires to accept the funds allocated by the Contra Costa County Health Services Emergency Medical Services Division in the amount of \$223,022.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Richmond that:

- The City of Richmond shall accept the allocation of \$223,022 from the Contra Costa County Health Services Emergency Medical Services Division.
- The funds which the City will receive are hereby appropriated towards program expenditures, under Fund 1007, Org 10706022 and Obj Codes to be determined.
- The City Manager, or his designee, shall establish a Budget Supplemental Fund revenue account under Fund 1007, Org 10706022, Obj 337378 for the deposit of the funds, which have been allocated to the City of Richmond.
- The Finance Director of the City of Richmond shall submit the necessary reports and summaries which are required by State law.
