

CITY COUNCIL RESOLUTION NO. 94-15

RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA SUBSTANTIALLY AMENDING THE 2010-2015 CONSOLIDATED PLAN WHICH DESCRIBES ACTIVITIES PROPOSED BY THE CITY WITH FUNDS FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME INVESTMENT PARTNERSHIPS PROGRAMS AND AUTHORIZING THE HOUSING DIRECTOR TO ENTER INTO CONTRACTS TO USE UNUSED 2011, 2012 AND 2013 FUNDS

WHEREAS, the City Council authorized the Housing and Community Development staff to file the Five Year 2010-2015 Consolidated Plan with the U.S. Department of Housing and Urban development and to provide such additional information as may be required on May 4, 2010; and

WHEREAS, the City of Richmond noticed a public comment period which commenced on August 22, 2015 and ended on September 22, 2015; and

WHEREAS, the 2010-2015 Consolidated Plan will be amended to allow the entire 2014 CDBG allocation, \$1,092,323, for the prepayment of the City's 1999 Section 108 loans and replace the originally proposed activities listed in the Fiscal Year 2014 Action Plan; and

WHEREAS, the 2010-2015 Consolidated Plan will be amended to use \$851,401 in unused CDBG funds from Fiscal Years 2011, 2012, and 2013 for the activities presented in the Public Hearing on July 21, 2015 and approved by the City Council on that date; and

WHEREAS, the City Council has received and accepted the Staff Report regarding this Resolution;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Richmond finds the above recitals are accurate and have served, together with the Staff Report, as the basis for the findings and actions set forth in the Resolution; and

BE IT FURTHER RESOLVED, that the City Council authorizes the Housing Director to substantially amend the 2010-2015 Consolidated Action Plan.

BE IT FURTHER RESOLVED, that the City Council authorizes the Housing Director to enter into contracts to use unused 2011, 2012 and 2013 funds.
