

**CITY COUNCIL RESOLUTION NO. 19-16**

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,  
AUTHORIZING THE ACCEPTANCE OF FUNDS ALLOCATED TO THE CITY  
FROM CONTRA COSTA COUNTY HEALTH SERVICES IN SUPPORT OF ITS  
HAZARDOUS MATERIALS DIVISION**

**WHEREAS**, the Contra Costa County has appropriated monies for the Hazardous Material Response Unit and Hazardous Material Emergency Vehicle Program under Agreement #22-402-15, approved by the Board of Supervisors on April 28, 1987; and

**WHEREAS**, the Contra Costa County Health Services Hazardous Materials Division will allocate funding to the City of Richmond Fire Department from July 1, 2015, through June 30, 2016, in an amount not to exceed \$388,480; and from July 1, 2016, through June 30, 2017, in an amount not to exceed \$394,427 who will maintain a Hazardous Materials Response Unit in West County; and

**WHEREAS**, the City of Richmond shall be awarded \$782,907 over a two-year period, commencing July 1, 2015, for projected expenditures through June 30, 2017; and

**WHEREAS**, the City of Richmond will ensure members of the Hazardous Materials Response Unit are trained to respond appropriately to any hazardous material event, including facilitating drills for such events; ensure members receive annual Hazmat physicals in accordance to National Fire Protection Association (NFPA) standards; and provide a training coordinator to facilitate any necessary and required training, and attend pertinent meetings on behalf of the Hazardous Materials Response Team.

**WHEREAS**, the City of Richmond desires to accept the funds allocated by the Contra Costa County Health Services Hazardous Materials Division in the amount of \$782,907, and Agreement #22-402-15 in its entirety.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Richmond that:

- The City of Richmond shall accept the allocation of \$782,907 from the Contra Costa County Health Services Hazardous Materials Division.
- The funds which the City will receive are hereby appropriated towards program expenditures, under Fund 1013; Org 11305022; Objs 400201, 400299, 400342, 400384, 400401, 400802, 400803, and 400811; Project 25H03.
- The City Manager, or his designee, shall establish a Budget Supplemental Fund revenue account under Fund 1013, Org 11305022, Obj 337371, Project 25H03 for the deposit of the funds, which have been allocated to the City of Richmond.
- The Finance Director or designee of the City of Richmond shall submit the necessary reports and summaries which are required by State law.
