

RESOLUTION NO. 83-16

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA AUTHORIZING THE ACCEPTANCE AND APPROPRIATION OF
\$600,000 AWARDED TO THE CITY THROUGH THE BOARD OF STATE &
COMMUNITY CORRECTIONS STRENGTHENING LAW ENFORCEMENT AND
COMMUNITY RELATIONS GRANT PROGRAM TO FUND EFFORTS TO REDUCE
VIOLENCE AND JUVENILE DELINQUENCY**

WHEREAS, the State government has made funds available through the Board of State and Community Corrections (BSCC) to improve, strengthen, establish or reestablish positive meaningful relationships between law enforcement and the community; and

WHEREAS, the City of Richmond is identified as a GRANTEE and entitled to a maximum of \$600,000 with the primary goal of increasing positive police practices through improved police department policies, training, civilian oversight; and

WHEREAS, the City of Richmond will increase community policing activities through expansion of the Richmond Ceasefire Program; and

WHEREAS, funding in the amount of \$511,598 to cover the in-kind match requirement is necessary; and

WHEREAS, the State of California requires the City Council hold a public meeting to consider the Police Chief's request for funding; and

WHEREAS, the Richmond Police Chief has submitted to the City Council a request that funds, which the City will receive under the allocations, be used to expand efforts to reduce violence and juvenile delinquency.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Richmond that:

1. The City of Richmond shall accept the allocation of \$600,000 from the Board of State and Community Corrections (BSCC).
2. The funds which the City will receive are hereby appropriated towards efforts to reduce violence and juvenile delinquency as detailed in the grant proposal.
3. The grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
4. The City agrees to abide by the terms and conditions of the Grant Agreement as set forth by the BSCC.
5. Staff support in-kind matching funds of \$511,598 is allowed.
6. The City Manager, or his designee, shall establish a Fund Organization/Object Code in the Munis System for the deposit of the funds which have been allocated to the City of Richmond from the Board of State and Community Corrections Grant Program.
7. The Police Department Accountant of the City of Richmond shall submit the necessary reports and summaries which are required by State law.
