

RESOLUTION NO. 87-16

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, AUTHORIZING THE ACCEPTANCE AND APPROPRIATION OF
FUNDS ALLOCATED TO THE CITY FROM THE STATE HOMELAND SECURITY
GRANT PROGRAM**

WHEREAS, the City of Richmond Fire Department applied to the California Office of Emergency Services and has been awarded funding through the State Homeland Security Grant Program in support of the Fire Marine Response Training Program in the amount of \$31,197; and

WHEREAS, the Contra Costa County Sheriff's Office has been appointed by the California Office of Emergency Services to act on its behalf for coordinating and managing State Homeland Security Grant Program funds and for reimbursing agencies for authorized expenditures; and

WHEREAS, the City of Richmond Fire Department desires to accept funding to reimburse personnel overtime and backfill under Project Number FY15 SHSGP Project J, which will allow the department to conduct additional in-house emergency marine response training.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Richmond that:

- The City of Richmond shall accept the reimbursement funds up to \$31,197 from the Contra Costa County Sheriff's Office.
- The funds that the City will receive are hereby appropriated towards personnel overtime and backfill to allow for additional in-house emergency marine response training, from an account to be established by the Finance Department.
- The City Manager, or his designee, shall establish a Budget Supplement Fund account under the State Grant Org and Object 10601022-334363 and assign a project code for the deposit of the funds, which will be reimbursed to the City of Richmond.
- The Finance Director of the City of Richmond shall submit the necessary reports and summaries that are required by State law.
- The City Manager, or his designee, shall negotiate and execute all agreements necessary for the implementation of this resolution.


