**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
APPROVING THE 2015-2016 CONSOLIDATED ANNUAL PERFORMANCE AND
EVALUATION REPORT (CAPER) WHICH DESCRIBES ACTIVITIES PERFORMED
BY THE CITY WITH FUNDS FROM THE U.S. DEPARTMENT OF HOUSING AND
URBAN DEVELOPMENT (HUD) FOR THE COMMUNITY DEVELOPMENT BLOCK
GRANT PROGRAM AND AUTHORIZING THE ACTING HOUSING DIRECTOR TO
SUBMIT THE 2015-2016 CAPER TO HUD**

WHEREAS, the Community Development Block Grant Program (CDBG) allocates grants to larger cities and counties to develop viable communities by providing decent and affordable housing, opportunities for expanding economic opportunities and improvements to public services specifically for low and moderate income households; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) acknowledged the City of Richmond (City) as a recipient of Community Development Block Grant (CDBG) Program funds; and

WHEREAS, the City of Richmond noticed a public comment period which commenced on November 21, 2016 and ended on December 6, 2016; and

WHEREAS, the Annual Consolidated Action Plan for 2015-2016 requires the preparation of a CAPER at the end of the program year, June 30, 2016; and

WHEREAS, by the agenda report accompanying this Resolution and incorporated into this Resolution by this reference (Agenda Report), the City Council has been provided with additional information upon which the findings and actions set forth in this Resolution are based.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Richmond hereby accepts that the above recitals are accurate and have served together with the Agenda Report as the basis for the findings and approvals set forth in this Resolution.

BE IT FURTHER RESOLVED that the City Council approves the 2015 – 2016 CAPER.

BE IT FURTHER RESOLVED that the City Council authorizes the Housing Director to submit the approved 2015-2016 CAPER to the U.S. Department of Housing and Urban Development.
