

CITY COUNCIL RESOLUTION NO. 13-17

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND
PROCLAIMING THE EXISTENCE OF A LOCAL EMERGENCY DUE TO
LANDSLIDE DAMAGE ON VIA VERDI IN RICHMOND, CALIFORNIA**

WHEREAS, Ordinance No. 4-73 N.S. of the City of Richmond empowers the City Council to proclaim the existence or threatened existence of a local emergency when said city is affected or likely to be affected by a public calamity; and

WHEREAS, said City Council has been requested by the Director of Emergency Services of said city to proclaim the existence of a local emergency therein; and

WHEREAS, said City Council does hereby find:

That conditions of extreme peril to the safety of persons and property have arisen within said city, caused by a hillside sliding on private property uphill and downhill from, and immediately adjacent to, Via Verdi roadway, about 570 feet north and east of the intersection with El Portal Drive, impacting cable, telephone, gas, water and wastewater utility lines and the City infrastructure including pavement, curb and gutter, and sidewalk commencing on or about 9:00 a.m. on the 23rd day of February, 2017; and

That the aforesaid conditions of extreme peril warrant and necessitate the proclamation of the existence of a local emergency.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that a local emergency now exists throughout said city; and

IT IS FURTHER RESOLVED, PROCLAIMED AND ORDERED that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this city shall be those prescribed by state law, by ordinances, and resolutions of this city, and by the City of Richmond SEMS/NIMS (Standardized Emergency Management System/National Incident Management System) Emergency Operations Plan, as approved by the City Council on April 01, 2008; and

IT IS FURTHER RESOLVED AND PROCLAIMED that said local emergency shall be deemed to continue to exist until its termination is proclaimed by the City Council of the City of Richmond, State of California.
