

RESOLUTION NO. 29-17

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND TO SET A PUBLIC HEARING ON MAY 2, 2017 REGARDING THE CITY'S INTENTION TO GRANT A FRANCHISE TO SFPP, L.P. TO USE OR TO LAY AND USE, OIL PIPES AND APPURTENANCES FOR THE PURPOSE OF TRANSMITTING AND DISTRIBUTING OIL AND PRODUCTS THEREOF IN, ALONG, ACROSS, UPON AND UNDER CERTAIN PUBLIC STREETS AND RIGHTS-OF-WAY WITHIN THE CITY OF RICHMOND

WHEREAS, it is the intention of the Council of the City of Richmond to grant to SFPP, L.P. Inc., its successors and assigns, a franchise for a period of ten (10) years to lay, construct, maintain, operate, repair, renew and remove or abandon in place a pipeline for the transportation of oil, gasoline, petroleum, gas of any type or nature, hydrocarbon substances, hydrogen, water, waste water, mud, steam, and other approved liquid or gaseous substances, together with all manholes, valves, service connections and appurtenances necessary and convenient to properly maintain and operate said pipeline in, under, along and across the public streets within the City of Richmond described as follows:

- Line No.8: Cherry Street, Morton Avenue, Collins Avenue, Giant Highway, San Pablo Avenue
- Line No.46: Castro Street, Vernon Avenue
- Line No.69: Castro Street
- Line No.70: Castro Street
- Line No.71: Canal Boulevard, West Cutting Boulevard, South Garrard Boulevard
- Line No.74: Seacliff Drive, Canal Boulevard, West Cutting Boulevard, South Garrard Boulevard
- Line No.75: South 2nd Street, 2nd Street, Ripley Avenue, 1st Street, Garrard Boulevard
- Line No.76: Wright Avenue, South 4th Street, Cutting Boulevard
- Line No.89: Canal Boulevard
- Line Nos.99&104: Castro Street

The grantee shall pay to the City of Richmond an annual franchise fee calculated pursuant to the provisions of Richmond Municipal Code Section 13.47 et seq. In the event that such payment is not made, the franchise will be forfeited.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Richmond as follows:

Section 1. That May 2, 2017, in the Council Chambers of the Council of the City of Richmond, City Hall, Richmond, California, is hereby fixed as the time and place for hearing all persons interested in or objecting to the granting of said franchise; and

Section 2. That the City Clerk is hereby instructed to print and publish, at least once within fifteen (15) days after the passage of this resolution, in the East County Times, a newspaper of general circulation within the City of Richmond, printed and published in the City of Richmond, this resolution of intention upon adoption;
