

CITY COUNCIL RESOLUTION NO. 42-17

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, RENEWING AND CONTINUING THE LOCAL EMERGENCY DUE TO
LANDSLIDE DAMAGE ON RIFLE RANGE ROAD FIRST PROCLAIMED BY THE
CITY OF RICHMOND ON MARCH 7, 2017**

WHEREAS, the City Council proclaimed the existence of a local emergency on March 7, 2017 due to the imminent hazard to Rifle Range Road resulting from a recent landslide activity; and

WHEREAS, the cause of the landslide is under investigation and is possibly due to soils deleteriously affected by a combination of heavy rains, winter storms, groundwater, water intrusion, or saturated soils; and

WHEREAS, the City Council found that conditions of extreme peril to the safety of persons and property had arisen as a result of continued movement of the landslide that imperils the roadway; and

WHEREAS, the City ratified the proclamation of a local emergency under Resolution No. 15-17 on March 7, 2017 as required by California Government Code Section 8630; and

WHEREAS, California Government Code Section 8630 requires that the governing body shall review the need for continuing the local emergency at least once every 30 days until the local emergency is terminated; and

WHEREAS, the City Council renewed and continued the declaration of a local emergency under Resolution No. 25-17 on March 21, 2017, under Resolution No. 30-17 on April 4, 2017, and under Resolution 37-17 on April 18, 2017.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Richmond hereby confirms the continued existence of the local emergency declared on March 7, 2017 on and around Rifle Range Road in the City of Richmond.

BE IT FURTHER RESOLVED that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law and the charter, ordinances, resolutions, and approved plans of the City of Richmond.

BE IT FURTHER RESOLVED that the Council of the City of Richmond hereby requests that the Governor of the State of California declare and proclaim a state of emergency in the City of Richmond with regards to the Rifle Range Road landslide.
