

**RESOLUTION No. 21-07**

**RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA IN SUPPORT OF SEIU LOCAL 790 IN THEIR TRANSITION TO SEIU LOCAL 1021**

**Whereas;** the City of Richmond members of SEIU 790 participated in a statewide election to restructure SEIU locals in the State of California; and,

**Whereas;** one aspect of that vote was to transfer all the Employer's employees represented by SEIU Local 790 from representation by SEIU Local 790 to representation by SEIU Local 1021; and,

**Whereas;** on March 1, 2007, all the City of Richmond's employees represented by SEIU Local 790 shall be represented henceforth by SEIU Local 1021; and,

**Whereas;** on March 1, 2007, the City of Richmond shall recognize SEIU Local 1021 as the exclusive representative of said employees with respect to wages, hours, and other terms and conditions of employment; and,

**Whereas;** SEIU Local 1021 accepts and agrees to be bound by the SEIU Local 790 MOU with the City of Richmond; and,

**Whereas;** SEIU Local 790 and the City of Richmond agree that all terms and conditions of the collective bargaining agreements between SEIU Local 790 and the Employer shall be adopted by SEIU Local 1021 and the Employer, and that where the contracts refer to SEIU Local 790 and/or the "the Union," all such references shall be understood to be references to SEIU Local 1021.

**NOW, THEREFORE BE IT RESOLVED,** that the City Council of the City of Richmond hereby congratulates the City of Richmond employees on their election to be represented by SEIU Local 1021.

**BE IT FURTHER RESOLVED,** that the City Council of the City of Richmond pledge to work collaboratively with the membership and leadership of SEIU Local 1021.
