

**RESOLUTION NO. 34-19**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, ACCEPTING AND APPROPRIATING FUNDS ALLOCATED TO THE  
CITY OF RICHMOND FROM THE CALIFORNIA OFFICE OF EMERGENCY  
SERVICES IN SUPPORT OF LAW ENFORCEMENT SEXUAL ASSAULT  
SPECIALIZED UNITS PROGRAM**

**WHEREAS**, the City of Richmond shall be awarded \$272,667 for accumulated expenses as it relates to a law enforcement sexual assault specialized unit for the period beginning October 1, 2018 through September 30, 2019; and

**WHEREAS**, a portion of the above funds will be utilized to allow for an on-site advocate from Community Violence Solutions (CVS), an advocacy group that provides services to sexual assault victims, for the period October 1, 2018 through September 30, 2019, not to exceed \$94,611; and

**WHEREAS**, the City of Richmond desires to approve a contract extension between the City and Community Violence Solutions; and

**WHEREAS**, the City of Richmond desires to accept the funds allocated by California Office of Emergency Services in the amount of \$272,667.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the City of Richmond

- The City of Richmond shall accept the allocation of \$272,667 from the California Office of Emergency Services;
- The funds which the City will receive are hereby appropriated toward program expenditures, under Fund 1006; Org 10691021; Objects 400201, 400299; Project 24112.
- The City Manager, or his designee, shall establish a Budget Supplemental Fund revenue account under Fund 1006, Org 10691021; Objects 334363, Project 24112 for the deposit of the funds, which have been allocated to the City of Richmond.
- The Finance Director, or designee, of the City of Richmond shall submit the necessary reports and summaries which are required by state law.


