

RESOLUTION NO. 51-19

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND
AUTHORIZING A SOLE SOURCE PROCUREMENT PROCESS FOR SELECTED
SPECIALIZED POLICE DEPARTMENT SERVICES**

WHEREAS, there are certain specialized services performed by certain specified agency vendors for the Richmond Police Department which occur every year; and

WHEREAS, the agency vendors that provide these specialized services are the only vendors that can provide said service; and

WHEREAS, the specialized services and the specified vendors are each year set forth in the Police Department budget as line items for budgetary approval purposes; and

WHEREAS, having the City Council authorize the City Manager to execute the contracts associated with the annual line items set forth and approved by the budget will expedite the contract approval process thereby increasing efficiency and reducing paperwork; and

WHEREAS, the annual line items that are specifically to be addressed in this manner are listed as follows:

1. SHARED COSTS – CLETS – CC COUNTY
2. CAL ID – CCC FORENSIC DIV CONTRACT
3. ARIES MAINTENANCE – CCC CONTRACT
4. ACCJIN SHARED COST – CCC CONTRACT
5. BOOKING FEES – CCC CONTRACT
6. ALCOHOL/TOXIC DRUG and CRIME EVIDENCE – CCC CONTRACT
7. SART EXAM – CCC CONTRACT
8. CCC AUDITOR ANNUAL JAIL INSPECTION – CCC CONTRACT
9. STATE OF CA – DOJ – LIVE SCAN FINGERPRINTING
10. DEPT OF CORONER & GUNSHOT RESIDUE EXAM – CCC CONTRACT
11. INMATE EXTRADITION – CCC CONTRACT
12. LAW ENFORCEMENT TRAINING CENTER – CCC CONTRACT
13. ANIMAL SERVICES – CCC CONTRACT
14. UNIVERSITY OF CALIFORNIA REGENTS-EMERGENCY SERVICES
15. EAST BAY REGIONAL COMMUNICATIONS SYSTEM AUTHORITY (EBRCS) – CCC CONTRACT

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Richmond that the City Manager is hereby authorized, for fiscal years 2019-2020 and 2020-2021, to execute the contracts listed below provided that the contract dollar amounts do not exceed the amounts listed for each fiscal year:

1. California Law Enforcement Telecommunications Systems (CLETS) - \$10,000
2. California Identification Division (CAL ID) - \$135,000;
3. Automated Regional Information Exchange System (ARIES) - \$45,000
4. All County Criminal Justice Information System (ACCCJIN) - \$20,000
5. Martinez Detention Facility intake fees - \$46,000
6. Alcohol/Toxic drug and crime scene evidence analysis - \$350,000
7. Sexual Assault Response Team (SART) examinations - \$40,000
8. Annual jail inspection and audit - \$18,000
9. Coroner & Gunshot Residue (GSR) examination and analysis - \$10,000
10. Out of State inmate extradition - \$4,000
11. Law Enforcement Training Center - \$19,000
12. Animal Services - \$700,000
13. East Bay Regional Communication System Authority (EBRCS) - \$178,000

The State of California contracted services includes:

1. Live Scan Fingerprinting - \$16,000
2. University of California Regents - \$5,000

BE IT FURTHER RESOLVED, that the Council of the City of Richmond hereby authorizes the City Manager to execute, and make amendments to, the contracts as needed to facilitate payment for Richmond Police Department services.
