

RESOLUTION NO. 69-19

**A RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA,
AUTHORIZING THE INSTALLATION OF TWO (2) FOUR-WAY STOPS AT 2ND ST &
CHANSLOR AVE AND 2ND ST & BISSELL AVE, TWO (2) TWO-WAY STOPS AT
WASHINGTON AVE & NICHOLL AVE AND MAINE AVE & 15TH ST, AND ONE (1)
ONE-WAY STOP AT SHANE DR & HULL AVE**

WHEREAS, the public safety and welfare of the City of Richmond require that certain actions be taken under Municipal Code Chapter XIV.

WHEREAS, in accordance with Section 14.28.010 & 14.28.020 of the Richmond Traffic Code, the City Council declares that the intersections of 2nd St. & Chanslor Ave. and 2nd St. & Bissell Ave is a four-way stop and all vehicles must stop prior to entering the intersection.

WHEREAS, in accordance with Section 14.28.010 & 14.28.020 of the Richmond Traffic Code, the City Council declares that the intersection of Washington Ave. & Nicholl Ave and Maine Ave. & 15th St. is a two-way stop and vehicles must stop at stop signs before entering the intersection.

WHEREAS, in accordance with Section 14.28.010 & 14.28.020 of the Richmond Traffic Code, the City Council declares that the intersection of Shane Dr. & Hull Ave. is a one way stop and vehicles must stop at the stop sign before entering the intersection.

NOW, THEREFORE, BE IT RESOLVED by said Council of the City of Richmond that the City Engineer is hereby authorized to erect and maintain stop signs at the intersections of 2nd St. & Chanslor Ave., 2nd St. & Bissell Ave., Washington Ave. & Nicholl Ave., Maine Ave. & 15th St, and Shane Dr. & Hull Ave as indicated above.
