

**RESOLUTION NO. 82-19**

**A RESOLUTION OF THE COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, FOR ON CALL ENGINEERING DESIGN SERVICES FOR AN  
AMOUNT NOT TO EXCEED \$600,000 PER CONTRACTOR PER YEAR OVER A  
THREE YEAR PERIOD WITH TWO (2) ONE YEAR OPTIONS FOR EXTENSION,  
FROM SEPTEMBER 2019 THROUGH JUNE 2022**

**WHEREAS**, the Richmond Water Resource Recovery Department anticipates that several projects funded by various funding sources will require the use of Engineering Design Services; and

**WHEREAS**, the Richmond Water Resource Recovery Department further anticipates that additional construction projects will arise during the period September 2019 - June 2022 that will require the use of On Call Engineering Design Services; and

**WHEREAS**, the project-by-project selection process for Engineering Design Services can take up to six months and involve significant per-project contracting costs; and

**WHEREAS**, the Richmond Water Resource Recovery Department has demonstrated that the use of a pool of On Call Contractor firms that have passed a competitive bidding process on an as-needed basis eliminates much of the delay and costs associated with project-by-project bidding; and

**WHEREAS**, in June 2019 the Richmond Water Resource Recovery Department and Veolia Water West Operating Services, Inc. issued a Request for Statement of Qualifications for On-Call Engineering Design Services through the City's BidsOnline system; and

**WHEREAS**, 1,645 firms received the Request for Statement of Qualifications, of which twelve (12) presented qualifications; and

**WHEREAS**, the twelve (12) statements of qualifications that the City received were reviewed by a panel consisting of Public Works Director Yader A. Bermudez, and Public Works Senior Civil Engineer Tawfic Halaby, and Veolia Water West Operating Services, Inc. Representatives Laura Pagano (Senior Capital Project Manager) and Gary Beach (Project Manager); and

**WHEREAS**, in evaluating proposals, the panel considered five criteria:

1. Proposal/Methodology and Approach to Work described in RFQ
2. Experience/Past Performance References
3. Project Team
4. Proposer Qualifications
5. Compliance with City of Richmond's Local Employment Ordinance and Living Wage Ordinance and Ban the Box Ordinance; and

**WHEREAS**, the panel accepted the qualifications of eight (8) firms, finding that eight (8) firms were highly experienced to provide On Call Engineering Design services for the City of Richmond for the anticipated professional services workload for the next three years with two (2) one year extension options; and

**WHEREAS**, the eight (8) firms selected (in alphabetical order) are:

- Advanced Hydro (Walnut Creek)
- Carollo Engineers (Walnut Creek)
- GHD (Emeryville)
- HydroScience (Berkeley)
- IEC (San Jose)
- NCE (Point Richmond)
- V&A (Oakland)
- VW Housen (Walnut Creek); and

**WHEREAS**, each On Call Engineering Design Services Contract with an approved firm would be for an amount not-to-exceed \$600,000 per contractor per year over the three year period September 2019 to June 2022; and

**WHEREAS**, firms selected for these On Call Engineering Design Contracts will provide services as requested by the City and/or Veolia Water West Operating Services, Inc.; and

**WHEREAS**, firms on the list will be asked to submit proposals for particular projects; and

**WHEREAS**, the Water Resource Recovery Department will issue per project Task Authorizations to Veolia and Veolia Water West Operating Services, Inc. will manage the subcontracts with these firms.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Richmond hereby authorizes the Water Resource Recovery Department to enter into Service Contracts for On Call Engineering Design Services, with the following firms for an amount not to exceed \$600,000 per contractor per year over the three year period September 2019 through June 2022:

- Advanced Hydro (Walnut Creek)
- Carollo Engineers (Walnut Creek)
- GHD (Emeryville)
- HydroScience (Berkeley)
- IEC (San Jose)
- NCE (Point Richmond)
- V&A (Oakland)
- VW Housen (Walnut Creek)
